On December 3, 2024, the U.S. District Court for the Eastern District of Texas issued a nationwide preliminary injunction against enforcement of the Corporate Transparency Act ("CTA"), including a stay of the CTA's Beneficial Ownership Information Reporting Rule. The IRS continues the Home Improvement Credits in 2024 The maximum annual credit of \$3,200 The credit is available for exterior doors, exterior windows and skylights, insulation materials, home energy audits, central air conditioners, natural gas, propane or oil water heaters and furnaces. There are also credits for electric vehicles.
